"Hong Kong Book Fair 2025" Exhibitor

Control of Obscene and Indecent Articles Ordinance

I understand that you have enrolled to be an exhibitor in the "Hong Kong Book Fair 2025" organised by the Hong Kong Trade Development Council, and would like to take this opportunity to introduce to you the Control of Obscene and Indecent Articles Ordinance (COIAO), Chapter 390 of the Laws of Hong Kong, with which you are required to comply.

Hong Kong is a free and open society. We cherish the free flow of information and respect the individual's right of access to information and freedom to publish. The Hong Kong Special Administrative Region Government's policy is to strike a proper balance between protecting public morals and our young people on the one hand and preserving the free flow of information and safeguarding the freedom of expression on the other. On this basis, the COIAO seeks to restrict the publication, circulation and display of obscene and indecent materials without stifling free expression and freedom of publication. The COIAO does not require compulsory pre-censorship before the publication of any article, but it is the responsibility of the publisher to ensure that the publication is in compliance with the COIAO.

The information provided in this letter aims to enable exhibitors in the "Hong Kong Book Fair 2025" to understand the statutory requirements in the COIAO. Under the COIAO, articles can be classified into three different classes –

- Class I (Neither Obscene Nor Indecent) article can be published to any person;
- Class II (Indecent) article can only be published to persons aged 18 or above; it has to be sealed in transparent wrapper (completely opaque wrapper if the front and/or back cover is indecent) and at least 20% of the front and back covers should contain the statutory warning notice; and the name, full address of the place of business and telephone number of the Hong Kong publisher should also be printed on the front or back cover of the article; or
- Class III (Obscene) article cannot be published.

It is an offence in law to publish an obscene article, or an indecent article without following the statutory requirements.

Classification of articles is carried out by the Obscene Articles Tribunal (OAT) set up under the COIAO. While the COIAO does not require a publication to be classified before its publication, if the publisher is uncertain about the classification of an article, he may submit it to the OAT for a ruling.
